

TERMS & CONDITIONS

The Teacher shall provide lessons to Students in the following area:

Grammar, Sentence Structure, Vocabulary, Reading Comprehension, Writing, English, Test Preparation

FEES PAYABLE TO THE TEACHER

Fees shall be paid based on grade level, and the session chosen. Fees may be adjusted from time to time and shall become effective after having given the Student (10)days notice.

PAYMENT

Payment shall be made immediately, before a session commences.

Accepted methods of payment: Internet Transfer

SCHEDULE OF LESSONS

Starting date of lessons will be discussed upon availability of the student.

CANCELATION OF LESSONS BY STUDENT

The Student may cancel a lesson by giving at least 24 hours prior notice to the Teacher, in which case no tuition fees will be incurred. However, a \$15 fee will be assessed if a student misses more than the maximum amount of sessions allowed.

CANCELATION OF LESSONS BY TEACHER

The Teacher may cancel lessons by giving 24 hours prior notice to the Student in which case no

fees shall be incurred. Where a lesson was pre-paid, the Teacher shall reschedule the appointment at a time agreeable to both parties.

LATE ARRIVAL

Fees are calculated according to the times stipulated in the schedule and no adjustment shall be made for time lost because of late arrival by the Student. Any lost time because of the late arrival of the Teacher shall be compensated for by extending a lesson by mutual agreement and by such an amount of time that was lost.

OBLIGATIONS OF THE TEACHER

*The Teacher undertakes to do all preparation prior to lessons and to structure lessons in such a way as to optimize time to the benefit of the Student.

* The Teacher shall keep confidential all information of the Student and shall contact other parties involved in the education of the Student only if given written permission by the Student/or Parent to do so.

* The Teacher shall not assign any of his/her duties or obligations under this teaching contract to a third party without the written permission of the Student.

* The Teacher shall at no time be required or obliged to execute homework or assignments on behalf of the Student.

OBLIGATIONS OF THE STUDENT

* The Student undertakes to assist the Teacher in identifying problem areas in which the

Students need specific help.

* The Student agrees that assignments, exercises or homework form an integral part of teaching and undertakes to complete such work timeously.

NO WARRANTIES

The Teacher makes no promises or warranties with regards to a Student's performance as a result of any tutoring provided.

TERMINATION

This teaching contract may be terminated by either party at any time by giving the other party (_3_) days prior notice.

RELAXATION OF TERMS

No relaxation, indulgence, waiver or release by any party of any of the rights in terms of this agreement on one occasion shall prevent the subsequent enforcement of such rights and shall not be deemed to be a waiver of any subsequent breach of any of the terms.

WHOLE AGREEMENT

This agreement constitutes the entire understanding between the parties with regard to the subject matter thereof and the parties waive the right to rely on any alleged expressed or implied provision not contained herein. Any alteration to this agreement must be in writing and signed by both parties.

MINORS

Where the Student is a legal minor, the Parent/Guardian shall enter into this tutoring contract on behalf of the Student and shall accept and agree to all the terms and conditions contained herein on behalf of the Student.
